The drawing of bridge designs that appears on the back of Euro notes represents “Cooperation and Integration.” Korea is often known as the “Land of Morning Calm.” The traditional principle of Korea’s international relationships always has been “peaceful coexistence.” Now, Korea will go from a hermit to a hub in the Far East. I believe that Asia will integrate in a more coherent way from now on. The conditions are different, but the spirit shall reflect those of the European Union, that seeks cooperation between nations and coexistence in peace.

The Yonsei-SERI EU Centre will act as a key link between Europe and Korea. Its activities are divided into 4 major categories: research, education, outreach activities, and exchanges. The EU Centre will promote EU studies in research and higher education. The expertise and information from the academy will reach and benefit a broad audience and the policy community in Korea. The Centre will also seek cooperation with EU-related institutions, nationally and internationally.

The Yonsei-SERI EU Centre will establish various support programmes for EU studies. It will provide scholarships to doctoral and master's students engaged in EU-related studies, reward outstanding Ph.D. dissertations, and provide research grants to post-doctoral researchers. In addition, the Centre plans to launch large-scale research projects to support leading scholars' EU-related research.

The Centre will assist Yonsei University in improving its bachelor's and master's courses on the EU in order to train EU experts and to make EU-related lectures available for students of various colleges of Yonsei. The Centre will also support extra-curricula activities through EU summer programmes, EU student symposiums, and mock EU summit meetings.

To deepen Korean students' experience in Europe, the Centre will operate student exchange and student internship programmes. The Centre will also promote research on the EU and exchanges between scholars in Korea and the EU

To promote the EU, the Yonsei-SERI EU Centre will engage in a variety of online and offline activities. These include hosting forums for Korean legislators and senior government officials, seminars for EU experts, Korea-EU symposiums, international conferences; writing opinion columns for Korea's major newspapers; and distributing bi-monthly EU Newsletters

Research outcomes on the EU will be published in a book format once a year. The results of key research projects will be released as separate publications as needed. One EU-related book will be translated and be published every year; while a volume of essays on analysing various EU policies will be published twice a year. Furthermore, the EU newsletter will be published every month, and researchers at the Centre will regularly write newspaper columns on EU policy trends.
